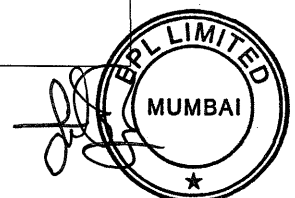

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, this is to inform you that Tubopack De Colombia S.A.S., a wholly owned step-down subsidiary of the Company registered in Colombia (the Subsidiary or Tubopack), applied for voluntary liquidation and liquidator was appointed as per applicable laws. The Liquidator has now informed that all the procedures and compliance have been completed relating to liquidation of the Tubopack on 30 June 2022 and accordingly the Tubopack De Colombia S.A.S stand fully liquidated as per applicable laws.

The liquidation of the Subsidiary was voluntary and as a part of internal reorganization and it will not affect to the performance or revenue of EPL Limited. Please note that the subsidiary was not a material subsidiary of the Company. In compliance with Regulation 30 of the SEBI Listing Regulations, relevant details are given here below.


