1. The Company has only one class of security with respect to voting rights i.e. Equity (equity shares with voting rights). 2. As disclosed earlier, on December 1, 2022, Epsilon PledgeCo Pte. Ltd. (Parent) and Epsilon Bidco Pte. Ltd. (Epsilon Bidco or Promoter) agreed to certain covenants that are in the nature of encumbrance in relation to an offshore facility availed by Epsilon Bidco for refinancing an existing facility. Parent, from the date such existing facility was refinanced, created a pledge on its entire shareholding in Epsilon Bidco. However, it is clarified that the Parent does not directly hold any equity shares in the Company. Accordingly, it is further clarified that Epsilon Bidco or Promoter has not created any pledge on the equity shares of the Company. 3. Regarding disclosure with respect to Significant Beneficial Owner (SBO), the ultimate beneficial owner of the Promoter Epsilon Bidco Pte. Ltd. is Ms. Melanie Mei Lan Ng. The SBO has redacted the sensitive personal information (such as passport details) in the SBO declaration furnished to the Company pursuant to the Companies Act, 2013. In case the stock exchanges require the passport number of the SBO in future, the passport number will be provided by the SBO.
